Sunday, January 27, 2019

St. Andrew's United Church, Lacombe, AB.

St. Andrew's United Church Annual Congregational Meeting was held in the sanctuary on Sunday, January 27, 2019 following a soup luncheon offered by the Outreach Team. There were 53 in attendance. See list attached. Jane Wilkinson took the minutes.

Opening Prayer – Marco Ste-Marie, Nancy Colton and Barbara Lieurance lead us in the opening prayer.

Welcome – Karen Yakimishyn – there were three documents for the meeting: Annual Reports, Annual Financial Report, and 2019 Budget.

Voting

There was a deficit last year of \$64,833. Discussion on expenses and contributions for 2018.

Bob Settle reported that the church has done historically well.

Lawrence Hrycan reminded us that our Vision, Mission and Philosphy is what we are all about.

We acknowledge that we come together as brothers and sisters in the One Body of Christ. When we remember that Christ is in our midst, and within each of us, it is easier to behave —with compassion, openness and love with honest dialogue and healthy boundaries.

Confidentiality: What's said in the group stays in the group unless there is full agreement and permission to share a piece of information. There may be things shared or learned that might help a broader audience. If so, obtain consensus for ways this information might be shared without violating the safety or privacy of any group member.

Respect one another: "Disagree without being disagreeable." Acknowledge the other person's point of view. Avoid hurtful comments or tone of voice. We can disagree and still remain friends.

Truly Listen: Sometimes the hardest thing to do is simply listen to a person without already thinking of what you are going to say back before they even finish. Confirm that you heard correctly before responding.

Be more committed to relationships than to "winning" or being "right." Stay open in your sharing and receiving. It is hard to have true dialogue with people whose whole goal is to prove their point or win their agenda.

When tension and misunderstanding arise, taking a break to cool down, asking or receiving forgiveness may all be appropriate strategies.



Update regarding the painting of the steps

When we became an Affirming Ministry within the United Church of Canada back in 2012, it was hoped that the work that was done through our discernment period, leading up to this congregational decision, would be taken on by our various groups and committees within the congregation.

However, there were several instances during 2019 that led our Affirm committee to reengage in this work. They brought a motion to the Board in June of 2019, asking for the Board support to paint a temporary rainbow on the steps leading to the church, to be done in time for Central Alberta Pride Week in August of 2019.

This rainbow was in keeping with the broader objectives behind being an Affirming Ministry, of living out this core value in a way that is <u>Public</u>, <u>Intentional and Explicit</u> (P.I.E.) and is a widely used approach to demonstrating PIE throughout the United Church community.

The paint was donated to us by Absolute Custom Designs in Lacombe. It is an interior latex paint by PARA Paints which was intended to fade over time.

The decision by the Board to support this welcoming statement has resulted in conversations within the church that presented many different perspectives on how we should publicly show our inclusivity.

The board has heard those concerns, particularly ones about safety and the impact on our historical building status. We have contacted Occupational Health and Safety and the Alberta Safety Council for input. We were provided with some suggestion to minimize the visual impact and informed us that as there was an alternative entrance this is not an OHS issue. It was also determined that there was no impact on our status as a historical building as the painting was not on the actual structure.

Discussion regarding ways that we can be public about who we are will be part of the discussions through the transition team conversations as we continue to build our community of faith profile in anticipation of calling a new minister.

As well the board will be revisiting the painted steps in the spring. As the paint fades, we will be working with the Affirm committee to look at alternatives to that can fulfill our commitment to be public about our inclusiveness

The Board of St. Andrew's

2019 Financial Report

2019 was a tumultuous year for St. Andrew's United Church. Our financial highlights for 2019 started with a budget in January 2019 being rejected by the congregation. At the 2019 AGM a recommendation was made for a budget review committee to be created with the intention of developing a revised budget which would be presented to the congregation in March 2019. The revised budget was passed with the provision that there would be a September congregation meeting to review and discuss the financial results to that date. Shortly after the March congregational meeting both ministers resigned with an end date of June 30, 2019. Our Intentional Interim Minister joined our Community of Faith on July 1, 2019 with a two-year commitment. All of this activity in the first half of 2019 had a big impact on our financial results with the overall effect of a reduction in wage expenses and many committees cutting back on their spending.

Some of the financial highlights from 2019 are:

- St. Andrew's posted a net income of \$26,235 for 2019. While we fell short in our projected income the reduction in wages and a general 'tightening of belts' more than offset the revenue shortfall. As well, our income was bolstered by a \$4,079.25 donation from UCW #2 for the purchase of the chair storage room in the auditorium. This is a departure from past UCW funded capital building improvements when they just occurred without being recorded in the accounting records.
- In 2019 there were various fundraising events in support of the church.

 In accordance with Canada Revenue Agency and United Church of Canada policy regarding churches and non-profit organizations we are now recording materially valued building improvements into the Balance Sheet of St. Andrew's. As such, in 2019 two such purchases were made and recorded:

Our team has grown since we first formed in June and we now feel we have a better representation of the congregation. Opportunity to provide input in the final Community of Profile will occur in the late fall with the intent to finalize it by January 2021. The Profile will serve as a critical piece of finding the right fit for our next minister.

We would like to thank all of those who have been engaged in our process. Your participation and willingness to share your stories and perspectives makes this a very rewarding task. The passion and commitment that the people of St. Andrew's have for this community is one of the greatest strengths we have.

Ministers' Reports

Reverend Sarah Fanning

"For now we see in a mirror dimly, but then face to face. Now I know in part; then I shall know fully, even as I have been fully known." (1 Corinthians 13:12, ESV)

These words by Paul are less familiar to us than the words about love that come before and after them from 1 Corinthians 13. Yet they are the words that I chose as the reading at our covenanting service in October of 2019, for they convey the sense of what I believe my role is with St. Andrew's United Church as your Intentional Interim Minister (IIM). My goal as your IIM is to work with you, asking questions and holding up a mirror to help us see ourselves as a community of faith, and help us discern together what God is calling us to do.

As a congregation, you set some goals for this interim period, mainly around identity, communication, and fostering change. Some of the highlights of the work we have done together in the last six months are:

- Getting to know our Board members, as well as the members of the Transition Team, and helping to provide resources, education, and support to them about what Intentional Interim Ministry is, as well as what our hopes and goals are for our time together in the next 18 months. Thank you to those who have served on our Board over the last while whose term is done, thank you to those who are continuing in their role, and thank you to those who will be joining. Your gifts and your service to our community of faith are greatly appreciated!
- Meeting with each of the congregational committees to talk about roles and responsibilities.
- Helping the board navigate through some of the positive and negative feedback around the painting of the steps.
- Fireside Chats focussed on helping us connect with one another, hear one another's stories, and begin to understand why this community of faith is important to us, and why we feel connected to it.
- Sermon series on the parables in Luke, focussed on finding ourselves in the stories.
- Advent candle-lighting series based on Mr. Rogers' Neighbourhood and the themes of welcome and being neighbours.
- I had the privilege of presiding at nine funerals, not only for people connected with our congregation, but also for our wider community (two of these funerals were in Olds, covering for their minister while she was on sabbatical, and one was in Innisfail while they were without a minister). Funerals are one of the many ways that this congregation lives out its mission of being a caring community to families in times of need.
- Working with Barbara to provide pastoral care to those in need. Much of my pastoral care time
 has been spent with funeral families, as well as a few families in crisis. I am greatly appreciative
 of Barbara's time and energy that she gives to our seniors, and how this role enables me to
 focus on my role as your IIM.

Looking ahead to our time together in 2020, the Transition Team will be hosting a number of Friday Fun Nights to continue to help foster connections with one another, and with our wider community. There is a book study planned for Lent (March 2020), as well as a sermon series based on the Mr. Rogers' Movie, *A Beautiful Day in the Neighbourhood*. We will continue to work on our goals around mission and ministry, as well as finding healthier ways to communicate and deal with conflict. It is hoped that by summer of 2020, the Transition Team will have a better glimpse in the mirror of who we are as a community of faith, so that in the fall of 2020, we can begin to prepare a profile which will be used when you search for your next minister.

Committee Reports

Ministry and Personnel (M & P) Committee

The M & P Committee of St. Andrew's is a committee of trust and confidentiality that provides support, assessment of and consultation with all ministry personnel and non-ministry staff of the church. Comprised of individuals from the congregation appointed to 3 year terms, the committee provides a liaison between and among the congregation and the ministers and other staff of St. Andrew's. As an advisory body, the committee makes recommendations to the church board on ministry and personnel matters. The M & P Committee is represented in the Church Board.

Our membership for 2019 was: Christy Wyse, Sandra Smith, Jim Dixon (replacing Dennis Ethier), Rick Lawrence (replacing Lawrence Hrycan), Winnie Settle, and Barry Brouwer. As of July 1, Winnie and Rick resigned, as their representation of Pastor Marco and Rev. Nancy was no longer required. Christy Wyse has completed her term, and is leaving the team, resulting in a vacant position to be filled, beginning in 2020.

Ministry Staff – Rev. Marco St. Marie and Rev. Nancy Colton both resigned from their ministry roles, in the springtime. St. Andrew's has now hired Rev. Sarah Fanning for a two year term as an Intentional Interim Pastor. Sarah is not represented by M & P, but is accountable to the board through the Transition Team.

Barbara Lieurance continued in her Pastoral Care role for the equivalent of 1 day per week (20% of fulltime).

Office Staff – Sonia Smith submitted her resignation in February. Byron Mickelson volunteered to perform the book-keeping role and the reporting of financial information to the Finance Committee and the rest of the board. Byron's effort in this respect is very much appreciated, and the restructuring of the financial reports has made them easier to understand. Byron is stepping back from this unpaid role at the end of 2019. Jane Wilkinson continues in the position of office administrator, and no decision has been made on how to proceed without Byron.

We appreciate the dedication and professionalism Amy (and her helpers) bring to this role. Flower Fundraiser. Amazing support of this event by volunteers, those who donated and those who attended resulted in a profit of \$1689 which was donated back into the church's general fund.


Also new this year, CD hosted a free Easter Egg Hunt. The event ran from 10-12 and was such a great success, we are planning on making it an annual event.

The Messy Church Ministry has been in existence since October of 2013. As many activities do at St. Andrew's, it relies heavily on volunteers. In addition to many adult volunteers, 18 different youth from St. Andrew's and the community have contributed their time this year. Families who participate have told us that they appreciate the youth involvement with their children.

This ministry runs from 5 to 7 p.m. the first Friday of each month. The participants are greeted and welcomed at the door, and then directed to the prayer station and the bulletin board. From 5 to 6 p.m. everyone becomes involved with arts, crafts, and activities geared towards the monthly theme. At 6 p.m. we all move into the Sanctuary where the minister or a facilitator ties everything together in a lesson. This ministry is blessed in that a minister is involved, unlike some other Messy programs. We sing 2 or 3 songs, grace is said, and then we move back to the auditorium for a meal and fellowship.



Volunteers are always welcome, whether it be assisting with a craft, a story, a game, a song, or with the food in the kitchen. Including our food preparation planning individuals, there are currently 16 people on the planning committee. Everyone is welcome to come and simply see what the buzz is all about. We are looking forward to another exciting year in 2020!

Report to St. Andrew's United Church, 2020

New Board Structure

In May, 2019 at the Special General Meeting, several important motions were passed. The name will remain as "Red Deer Presbytery Camps Society --operating as Kasota East Camp" which is the historical name for KEC. The Board will now be made up of 6 - 8 members: 4 Executive, and up to 4 members at large. Our programing will continue to reflect our United Church theology through the hiring process. Our charitable status with Canada Revenue, and our Bylaws ensure that we will remain a United Church ministry.

The Board for 2020 is:

Chair: Shari Hanson, Vice Chair: Jim Watson, Treasurer: David Martin, Secretary: (vacant), and the following Directors-at-Large: Mandy Alcide, Rev. Nancy Nourse, and Amity Sponholtz. There is one vacant Director-at-Large position.

Some positions that were voluntary have been re-organized and will now receive payment for their work: The Director of Summer Programing and the Director of Camp Operations replace the Executive Director. Megan Anderson will be responsible for Summer Programming and Angela Wyman Richter will be responsible for: Registrations, and Rental Agent. The Property Steward, Bookkeeper and Cleaner will be paid as set out by their contracts which are still being developed. These are year-round positions.

The **new Bylaws** have been submitted to Service Alberta for approval and implementation and to Chinook Winds Region

Camp registration was the highest ever for: Family Camp--111 campers, K2--49 (tied with 2017), and K7 at 76 campers. We need 2 more cabins (approximately \$48-49,000 each) since we had to turn campers away for K4, K5 & K7. Many times staff had to sleep on cots instead of bunks, which is not very restful or practical in the long term. Campership sponsored 55 campers this year. This year we will be capping camperships for each camp and offering alternatives to the parents if that camp is at capacity.

Rentals have also gone well. May, June, September, October continue to be very popular and Angela is booking into 2021.

Promotions Committee raised \$3,600 from the Spring Flower Fundraiser with 7 congregations taking part. Poinsettia sales were \$1,542.50 with 4 congregations taking part and 2 others participating with them. Cow Patti Theatre raised \$6,436.00, our most successful events. The Crafty Ladies Retreats in Feb and October have raised approximately \$4,000.00 each year.

Promotions and fundraising will continue to be important since Camper Fees now only cover approximately 40% of the cost. In order to be competitive and accessible, more money will need to come from other sources of fundraising. (Ask me about using the term "Revenue")

Financial Report and Budget: First of all, after many years of dedicated service Charlie Ball is stepping down as Treasurer, Bookkeeper and Financial Wizard for Kasota to take on other duties. Our new Treasurer is David Martin. Our bookkeeper is Jen Nesbit.

I will have a fresh copy of the Budget available, the highlights are that we are still able to pay the bills and do some ongoing maintenance. We may need a new boiler for the washhouse (\$5-6,000.00). There was \$12,000 in one-time expenses. As stated above camper fees only cover +/- 40% of our needed revenue. The fees also only cover +/- 40% of the cost of running the camp. For 2020 we anticipate \$325,000 in revenue and \$337,700 in costs which equals a deficit of \$12,700. These calculations do not include the \$100,000 donation from Blackfalds United when the church was sold. The KEC Board will be doing some serious consideration about how to best use these funds over the long term, i.e. best stewardship practices. Congregations who have supported Kasota in the past continue to do so. Chinook Region made a grant (similar to what Presbytery did in the past).

We will continue to encourage the efforts of the Camp Champs to promote Kasota and fundraising for the camp. One very helpful way is PAR which can be set up through your local congregation. Even \$10 a month through PAR for 12 months can add up to \$120 per year. If 100 families took part---WOW!

Overall, we have had a good year at Kasota and we look forward to 2020.

Once again, many thanks to the folks at St. Andrew's United for your support and prayers.

Property committee

After a productive year I would like to thank everyone that has helped with all the projects that were done. It's always great to see how everything gets done with the help of so many different people.

This past year there were a few big projects again.

- -The east and south wall of the sanctuary were to be replaced with new brick. The bricklayers were behind with all the catching up they had to do after winter that they delayed our project to a point that they couldn't finish it due to the temperature dropping below zero. We had the option of tarping in the walls so they could work through the winter but that would have been too costly. We decided to postpone the project until next spring.
- -In the back of the auditorium there was a room built to store all the chairs and some tables. There are new chair racks and there were some chairs added to the fleet. This was a great idea from the UCW Unit 2 that took care of this project.
- -The auditorium got all new LED lights. The old fixtures needed to be replaced, some of the coating on the wiring was starting to strip off. This could have easily caused a fire if we were to leave it as is. The LED fixtures will also take a lot less power to run compared to the big old lights that were in there.
- -The new floor got installed in the auditorium, the stage, both staircases, upstairs hallway, copy room and upstairs bathroom. It sure is nice to see the old green tile gone, lots of tiles were chipping off and it wasn't a level surface anymore. This new floor is seamless and is durable. It has a 10-year warranty on any product failure as well. A big thank you to UCW Unit 2 that picked the colour and donated the money for the project and to all the people that helped moving furniture and cleaning up after install.
- -All 8 furnaces got a good cleaning this fall. After the new floor install and a few years of not cleaning the ductwork it was time to get everything free from dust. All filters were replaced, and the furnaces had a check over to make sure they keep running this winter.
- -The stage in the sanctuary got a nice new handrail to assist people that have difficulty getting up on the stage.
- -The daycare downstairs got an exhaust fan installed in the bathroom to meet the code they must follow.
- -And of course, there were lots of smaller projects that were done along with all the regular maintenance.

Volunteer Link is a registered Canadian charitable organization that is a partnership of 8 local churches including St. Andrew's.

Our volunteers assist those in the community, primarily seniors, requiring rides to medical appointments as far away as Calgary , visiting and completion of temporary tasks. In 2019, we provided 907 hours of volunteer work. In 2018, the number was 800 hours. There is no fee for the services we provide to our clients.

We have a strong affiliation with Lacombe FCSS, and any excess funds we have in a given year, we donate to the Lacombe FCSS Benevolent Fund.

Our office co-ordinator is Sheila Chapman and she works on a regular part-time basis from St. Cyprian's Anglican Church in Lacombe.

We rely on our funding from grant(s) and also donations from private individuals. As we are a registered charity, we are able to provide charitable tax receipts.

As the number of volunteer hours we contribute increases, we require more drivers and others to visit seniors in their homes. Please consider volunteering for this wonderful organization. You will find the experience very rewarding."

"Walking for Common Ground"

CENTRAL ALBERTA FOODGRAINS PROJECT

"The 24th year for the Central Alberta Foodgrains Project was a very challenging one, as it was for all Central Alberta farmers. The 70 acre wheat crop was seeded on May 18th and then due to poor harvest conditions, was not harvested until October 30.

After all crop proceeds and cash donations were received and expenses paid, we were able to send \$41,000 to the Canadian Foodgrains Bank in Winnipeg to help with feeding the hungry in the world.

Thank you to all the farmers that helped us produce our crop, and all others that helped in areas such as soil testing, soil preparation, seeding/fertilizing, spraying, trucking and of course, our cash donors and local agri-businesses that donated inputs. This year we were blessed to receive a \$25,000 donation from the Blackfalds United Church from the sale of its building. Some of these funds have been forwarded to Winnipeg and some held in reserve to assist with future crop input expenses and any land rent.

We also received a \$1500 donation from Whitehorse United Church from a reusable produce bag fundraiser it held in the spring of 2019.

2020 is a special year for us, as it is the 25th anniversary for our growing project. We have already secured approximately 140 acres of land to utilize west of Blackfalds at the Woodynook and Aspelund Roads corner. We are one of over 30 growing projects in Alberta and over 200 in Canada. The Canadian Government continues to match funds raised at a rate of 4 to 1.

We will be holding a special celebration dinner in early April for our 25 years. Watch The Morning Messenger for full details in the winter months.

St. Andrew's has always been an important part of our growing project. Church members have donated land, time, fuel and machinery and cash to the success of our 24 years to date. Last year, the Canadian Foodgrains Bank assisted over 800,000 people in 36 countries, so the need is still huge and we are confident that St. Andrew's support will continue to be forthcoming."

Friends of Guatemala (aka FRoGs) - 2019 in Review

First of all, Friends of Guatemala would like to say a big **Thank You** to the congregation of St. Andrew's for your support of our fundraising, and for the generous donations that have been made through offerings and the church office.

Great news from Rosario . . . Clinica Maya has built a new three story clinic, so is now able to help more women and their families with their health needs. This is an organization that we have supported for many years with funds and friendship. Rosario came to visit Lacombe several years ago, and we visit her clinic during our trips to Guatemala.

Fraternidad de Presbiteriales Mayas has reported that the food security project in El Rincon, San Martin in Guatemala has begun, and is going well. Our contributions to this project help with purchasing supplies like seeds and structures, such as chicken coops, as well the services of an agronomist to help with educating and training. This is a project that helps the community learn how to grow food for their own consumption as well as to sell. The goal is that this community project will be self-sustaining in three years.

Last April the Friends of Guatemala hosted a wonderful concert by Gospel 792, a local band that performs country gospel music.

Valdy returned to St. Andrew's on November 23 for a sold-out concert as a fundraiser for Guatemala. He still puts on a great show, and is such a friendly and personable fellow. ©

We are hoping to have someone come and speak to us this year about Fundacion de Antropologia Forense de Guatemala, and the work she does there through this organization.

The trip to Guatemala did not happen last year, but we are hoping to do it this year. The dates would be first two weeks of either July or November. The trip is coordinated through CEDEPCA in Guatemala, which will include visits to El Rincon and Toj Alic, as well as long-time friend Rosario with Clinica Maya, among other places and organizations. This trip is an immersive learning experience, an opportunity to learn about the people of Guatemala, to meet and talk with them, and see what life is like for them. Lacombe Community Refugee Effort

Annual Report

St. Andrews United Church donated half of the 2018 Christmas Eve donations to the Lacombe Community Refugee Effort. That was a welcome boost to our funds. Thank you to all who support with money, materials and encouragement. Together we have made a difference.

Our core committee continued to meet intermittently and stayed in touch through email and phone. We have added one new member and welcome anyone who would like to become more involved.

The Al Omar family met a huge challenge last summer when Bashar had so much pain and illness that he couldn't work. There were many medical appointments and diagnoses include rheumatoid arthritis. His employer provided some disability insurance while tests and medications tried to improve the symptoms. Now Bashar is heading for more English classes. That will be the first step so he can consider training for a less physical job.

Mid summer we finally got word that Khadija and her children were listed for flights, but it took until November 19th. By then the unrest in Lebanon had resulted in massive protests, blocked roads and the closure of their banks. We worried and passed messages until we knew they were safely in the air. They had to stay overnight in Toronto and there was a support group there who made sure they were fed, transported and put up in a hotel. The next afternoon they arrived at Edmonton airport and a bus load of friends, family and committee members met them there.

Generous people here in Lacombe had been donating furniture, housewares and clothing for a couple of years. On December 15 Khadija signed a lease(co-signed by our committee) on a lovely tri-plex with a bedroom for each of them. All the donated items were moved in and it is a comfortable home.

Mohammed and Marwa started school in December. Khadija had to wait for level one English classes which start late January.

Lacombe Community Refugee Effort will support Khadija's family for one year financially and will stay involved beyond that to the degree that she is comfortable with. Last year we started a file for an Eritrean man trying to bring his twin brother. While our legwork did help, John found an Eritrean community here to take over the file and now his brother is here in Alberta. We have started our next file in hopes of bringing Bashar's younger brother, his wife and their young children from Lebanon. Hopefully, the process will be faster this time.

Affirm St. Andrew's committee work focuses on making sure that all who enter our church feel welcome and genuinely included in this community. It is important to our committee that no person be marginalized for any reason. We dream of a diverse church where differences are celebrated and cherished. Every individual is important to our congregation and all are valued and offered a sense of God's unconditional love.

This June, with new members and renewed enthusiasm, Affirm St. Andrew's began to meet regularly again. One of our main objectives for the committee was that we need to be more vocal about our affirming status and our complete welcome of all people. Our affirming status needs to be more visible and obvious to newcomers to Lacombe and area as well as our community of faith. <u>All</u> are welcome including but not limited to our LGBTQ friends and community members. We need to reinforce for our most vulnerable church attendees that St. Andrew's is a safe and secure place for all to worship.

In keeping with our broader objective and the national, Affirm United, perspective that affirming churches should be <u>Public</u>, <u>Intentional</u> and <u>Explicit</u> (P.I.E.) we undertook a few projects. We sent two of our members to the Affirm United Annual Conference which took place in July and are committed to educating our community of faith about what was learned there. We took part in the Red Deer Westerner Days Parade by joining the Pride Float. We painted a rainbow of welcome on the front steps of the church during central Alberta Pride week and we held a vigil for the Transgender Day of Remembrance.

Other projects we undertook were to place the wheelchair ramp back in the sanctuary and reinstate our large print bulletins to reinforce our attitude of inclusivity. Many of our committee members attended an event at Hillhurst entitled "Does Church Matter" exploring why people attend church and how those reasons have changed over time. We also helped organize and participated in our service to celebrate becoming affirming and recognize that it has been 50 years since the decriminalization of homosexuality.

Our committee maintains a bulletin board in the auditorium. As well, we continue to maintain brochures for the pews and try to ensure that all feel welcome. We recognize special national and international days and maintain a presence on St. Andrew's Facebook page. We are

committed to providing books and resources for members of our congregation and those seeking support.

It was 8 years ago that members of St. Andrew's voted to become an affirming congregation. Through that process, we at St. Andrew's have found a clearer sense of who we are. We aim to be inclusive, supportive and accepting of all.

And all means all.

We thank all of you who have helped to move us toward our vision and look forward to your continued support.

In January, we cleaned the kitchen from top to bottom. From July until December we were responsible for making sure the kitchen was stocked with supplies. This ensures the cupboards are full for coffee Sundays.

LEGACY FUND

"The Legacy Fund was established as a savings fund for St. Andrew's in 2006.

The balance as of Dec. 31, 2019 is \$63,382. There have been no significant contributions to the Fund in the last 3 years.

Each year, all income earned on the Fund plus 50% of any new contributions are eligible for use by St. Andrew's on this basis: 40% Congregational use, 30% Local Community use and 30% World At Large use.

A donor may request that his/her principal contribution be totally left in the Fund.

At the Annual General Meeting, the Congregation votes as to how the funds will be used. Funds cannot be used for administrative purposes. This year \$400 is available for congregational use. \$300.00 is available for Local Community use and \$300 for World At Large use.

In November each year, a notice is placed in The Morning Messenger as to what amount is likely available for distribution at the following AGM. Congregational members/adherents make suggestions to The Legacy Fund Committee as to how the congregational portion may be used. Outreach Team advises as to how the other two distributions may be utilized.

There are many ways to contribute to the Fund, such as cash donations (tax receipt provided by the Church), bequests in wills, purchase of annuities, donations of investments such as stocks that receive preferred tax treatment.
